It is understood and agreed that MVC assumes *no liability for injury, damage, loss, accident, medical expenses, delay or irregularity* which may be occasioned for any reason whatsoever, including but not limited to, its own acts or omissions or the acts or omissions of any company or person engaged by MVC for the purposes of transporting or housing the Participant, or for the purpose of carrying out the arrangements of any tour. MVC reserves the right to substitute living accommodations of similar quality to those specified in the itinerary and to cancel any tour prior to departure, in which latter case a full refund will constitute full settlement to the Traveler. No refund will be made for any unused portion of any tour unless arrangements are made prior to departure from Canada. As a Christian organization our witness is very important. The purchase or use of illegal drugs, alcohol or tobacco products is strictly prohibited throughout the trip. MVC reserves the right to send any team member home at their own expense, if there is an infraction of the rules or if deemed necessary by the MVC's Missionary Representative in order to protect the safety, witness and work of the ministry within the Countries. You will be responsible for any costs incurred by your actions. Thank you for your courtesy and co-operation with MVC's rules and the local customs of the countries.

MVC accepts *no liability or responsibility for losses of any kind whatsoever or additional expenses to the Participant due to delay or changes in air or other services, sickness, weather, strike, war, quarantine, or other causes.*
